What we can recycle:

TYPES OF INFORMATION TECHNOLOGY AND TELECOMMUNICATIONS EQUIPMENT:

- Server, personal computers and computer displays
- Printed Circuit boards
- External power supplies and computer parts, automatic data processing machines, networking equipment, power supply accessories
- Devices for the collection, storage, processing, presentation or communication of information by electronic means
- User terminals and systems including retail store and point of sale (POS) machines, calculators and self-service kiosks, ATM, Automated checkout equipment, check out equipment, cash registers, phones, answer machines and related accessories
- Other products or equipment for transmitting sound, images or other information by telecommunications.
- Electrical motors

TYPES OF TELECOMMUNICATION CARRIER AND COMMERCIAL EQUIPMENT:

- O Cellular network base station equipment
- Building automation and surveillance equipment of all types
- Sound amplification and public address systems.

MISCELLANEOUS ELECTRONIC WASTE:

- Electrical and electronic tools such as drills, saws, sewing machines, power tools, riveters, welders, solders, mowing and other gardening equipment
- Consumer equipment such as radios, televisions, video cameras and recorders, Hi-Fi recorders, audio amplifiers, musical instruments and home medical electronics. Note CRTs (Cathode Ray Tube) TVs are not directly recycled but Sircel will facilitate downstream recycling
- Automatic dispensers such as automatic dispensers for hot drinks, bottles or cans, money, solid products and all appliances which deliver automatically all kind of products

- Medical devices (except for all implanted and infected products) such as radiotherapy, cardiology, dialysis, nuclear medicine, fertilization testing and laboratory equipment, pulmonary ventilators, analysers, freezers and appliances for detecting, preventing, monitoring, treating or alleviating illness, injury or disability
- Small household appliances such as vacuum cleaners, carpet-sweepers, hair cutter, hair dryer, electric tooth brush, shaving appliances, fryers, sewing, knitting, weaving appliances, electric knives, irons, scales, clocks, watches and equipment for measuring, indicating or registering time and hand held electrical devices
- Large household appliances such as large cooling appliances, freezers, washing machines, clothes dryers, dishwashers, electric stoves, cookers/ovens, electric hot plates, microwaves, electric heating appliances, electric radiators, electric fans, air conditioner appliances and other exhaust ventilation and conditioning equipment
- ⊙ Toys, leisure and sporting equipment such as video games, sports equipment with electric or electronic components, coin slot machines, hand-held video game consoles, electric trains or car racing sets and computers for sporting activities such as biking and diving.
- ∠ Lighting equipment such as straight and compact fluorescent lamps, low pressure sodium lamps, high intensity discharge lamps, including pressure sodium lamps and metal halide lamps, other lighting or equipment for spreading light with the exception of filament bulbs and luminaires for fluorescent lamps with the exception of luminaires in households
- Monitoring and control instruments such as smoke detectors, heating regulators, thermostats, measuring, weighing or adjusting appliances for households or laboratories and other monitoring and control instruments used in industrial installations (eg in control panels)

BATTERIES

- Smoke detectors with radioactive isotopes
